Purpose

Innovation is the key to the efficient and sustainable development of the construction industry. The Construction Industry Council (CIC) thus encourages innovation in construction to cultivate new ideas. The CIC Innovation Award (the Award) aims to spearhead development of new concepts to enable continuous enhancements in the construction industry of Hong Kong. It also aims to recognise new technologies and scientific breakthroughs by academia and industry practitioners, as well as to arouse international awareness on achievements in research and innovation in the construction industry of Hong Kong SAR, the Mainland China and overseas.

Scope of Entry

The innovative idea in the proposal of each entry must focus on one of the following subject areas:

- 1. Construction materials new construction materials beneficial to the built environment or conventional construction materials which are more sustainable
- 2. Construction technology procedures and techniques such as prefabrication, automation, robotics, etc in construction which can be applied to different projects
- 3. Construction management management tools and applications that enhance safety, environmental protection, project management and productivity in construction

Eligibility

- Local applicant(s) must apply for the Award under one of the following categories:
 - Local Academia: The applicant must be an academic holding a full-time teaching appointment or a student currently studying in an institution offering higher education in Hong Kong SAR. The institution must be one of the eight institutions funded through the University Grants Committee.
 - Young Innovator (Local Academia): The individual applicant / each member of a team must meet the above eligibility requirements and must be below the age of 40.
 - Local Industry Practitioners: The applicant must be a construction industry practitioner in Hong Kong SAR. Applications under this category can involve an overseas project conducted by the applicant.

- Young Innovator (Local Industry Practitioners): The individual applicant / each member of a team must meet the above eligibility requirements and must be below the age of 40.
- International Academia and Industry Practitioners: There is only one category for international applicants (Mainland China and overseas). The applicant must be an academic holding a full-time teaching appointment or a student currently studying in an institution offering higher education or a construction industry practitioner outside Hong Kong SAR. There is no Young Innovator Award for international applicants.
- Applicant(s) may either enter the competition in his / her individual capacity or in a team consisting of no more than four persons.
 - Each individual member of a team must be eligible to enter into the competition under one of the above five categories. However, if a team consists of team members eligible under both categories, the team should submit their application in the category which the lead applicant belongs to.
 - A team in the academia category may comprise of both academics and students.
- Each applicant / team can only submit one application under each category.
- Only one application can be submitted for each innovative idea / project.
- Written consent must be obtained from the owner of the innovation if the applicant(s) is not the owner.
- The CIC and / or the Judging Panel reserve the right to disqualify or determine on the eligibility of the Applicant(s).

Submission

The Judging Panel may conduct site visit if necessary. For Local Prizes, at least one member of the shortlisted teams or the individual applicant MUST attend a panel interview to present and elaborate their ideas as well as to answer questions from the Judging Panel. Absence will result in automatic disqualification. For International Grand Prize, at least one member of the awarded team is required to deliver a presentation in the Award Presentation Ceremony to be held in Hong Kong SAR.

Judging Criteria

Entries will be judged against the following criteria:

Innovation and Originality (40%)

The submission is able to demonstrate new and creative elements which are pioneered either in Hong Kong SAR or from a global perspective. The entry must be the original work of the applicant(s).

Impact (40%)

The submission is able to demonstrate how the innovation will have a positive impact on construction by comparing the current state and the expected state of construction after application of the innovation.

Applicability (20%)

The submission is able to demonstrate the likelihood of the adoption of the innovation with a descriptive roadmap on its transfer from the laboratory to the market.

Judging Panel

The Judging Panel comprises a diverse group of local and overseas experts.
